Tom is to be commended for the terrific job he did in organizing the Austin relays. His diplomacy in making sure everyone got to swim on a relay really contributed to our great team spirit.

This year's Hour Swim was once again in the capable hands of Art Smith. Our club has had the fortune of sponsoring this National Championship for several years and it has always been a big money maker for the Club. DC Masters has also been awarded the Hour Swim in 1989, but the future is hazy after next year, as other clubs have expressed interest in benefitting from sponsorship of the event. Art has tackled the Hour Swim for a number of years and as expected did his usual excellent job.

for registration information and materials. All participants must also be members of DC Masters. DCM membership was \$10 for 1987-88. The DCM fee can be added to the initial \$150 deposit for swimmers who are not currently DCM members and who do not wish to become a member before September 19.

**Snow policy:** As remote as it seems now, occasional "snow" days are likely in winter. There will be no swimming only if *Arlington schools* are closed. If Arlington opens late, we swim as usual. If Arlington is closed anyway (school holiday or some such), use Alexandria schools as the guide. If Alexandria schools were to be on holiday, use Arlington County government. If you are still not sure, play it safe. Sleep in.

**Special needs:** As in the past, every effort will be made to accommodate swimmers with special needs or problems. Those swimmers should talk to Art, Sue or Jim. There are also provisions for out-of-town swimmers to swim with MSP temporarily (one week at no charge and \$15 a week thereafter; USMS membership required) and for potential newcomers to try the program a couple of times before making a firm commitment. Anyone who is not a fully paid, appropriately registered member of MSP must contact Art, Sue or Jim before swimming.
